

# General Data's Protection Regulation Jan Roemaat Koel en Vrieshuizen B.V. (hereinafter referred as Roemaat)

## Background and contents of this privacy statement

The foundation for collecting personal data of clients is offering our services.

## Personal data we collect

Roemaat keeps the following information on your business:

- Company Name;
- Address;
- Phone numbers:
- Email addresses;
- VAT number
- Storage data (quantity/sort product);

With this information your company can be identified. Personal data are for example your company name or email address.

Part of these personal data we only collect when you provide. These personal data can be your name, address, email address or phone number.

• Information about our services which are requested.

Some of your personal data will be collected automatically when you visit our website or using our products. To this end, all of the following types of information may include:

• Our IP-address (Internet Protocol)

## Will your data be shared with third parties?

We can share your personal data with third parties in the following circumstances:

- When it's necessary to provide a product or service which you requested;
- When it's authorized by the law or is necessary for a legal proceed;
- When it's necessary to protect the legal rights and properties of Roemaat, including the safety of our services;
- When it's necessary to protect the personal safety or the property of Roemaat, or other rights of the public of Roemaat or their customers or employees;
- When it relates to the sale of our entire company or a part of it.

When we are legally forced to share your personal data with third parties, we will try to inform you in advance, unless this is illegal.

If we are involved with an merge, acquisition or the sale of assets, we will respect this privacy policy and inform all users if your personal data will be communicated with third parties. Or when there will be an other privacy policy for your personal data.

### Which right do I have concerning my Personal Data?

You have the right to ask us how we process your Personal Data, what is the purpose of the processing and to who we have shared this information with.

You have the right to ask us to update, correct our remove your Personal Data at any moment (if this does not affect the services which we provide to you).

We can decline your request in case this endangers others, it's irrational, repetitive or requires unreasonably large efforts.



Unless you ask us to remove your Personal Data, we can save your Personal Data for one year after you are resigned as an client (but usually we don't save your Personal Data longer than necessary for the purpose of collecting your Personal Data).

You have the right to unsubscribe from collecting certain data collecting by us or by a third party, including Personal data and not Personal data.

You can expect that we will protect and secure your Personal Data. We work hard to avoid unauthorized access, unauthorized changes or destroying any information that we collect:

- We will respect to this Privacy Policy regarding to all the information we keep from you;
- We will limit the use of your Personal Data and guarantee that everyone who which received this information will handle this information with privacy.
- We have accepted physical, technical and administrative procedures to guarantee and secure the information we collect.

### **Modification of Privacy Statement**

We have the rights to modify this Privacy Statement at any moment. If there are significant changes, we will mark these changes and try to inform you. We will save the previous versions of this Privacy Statement in our archive.
